Increasingly, EURATEX is invited to participate in events around Europe and beyond, to present our perspective on the EU Textiles Strategy and the (many) specific regulatory initiatives resulting from that. Such participation is a good occasion to inform companies about the upcoming changes, but also to get feedback/input from these companies and to increase EURATEX' visibility in the textiles ecosystem.

At the same time, EURATEX has a tradition of co-organising its annual convention, often in close cooperation with one of its members. So far, these events had a strong "local" contents; mobilising the entire European textile community has been quite difficult.

Against this background, we suggest a more systemic approach, whereby:

- we identify the most important events (fairs and conferences) in 2024, where EURATEX should be present, with different levels of involvement, according to the importance of that event;
- we upscale the General Assembly (organised in Brussels in June) to a slightly bigger event, fully focused on the EU policy agenda;
- we do no longer schedule a separate EURATEX Convention, but actively participate in existing events, as mentioned in the 1st point.

EURATEX' members are invited to comment on this approach, on the proposed list of events and the level of involvement, during the Board/DG meeting of 25 October.

Furthermore, we include in this note the proposed **statutory calendar**, which also includes the timetable for the EURATEX' Board nominations and elections of Presidents and Vice Presidents, for review and adoption on the 25th.
